## Bequests

Over the past 160 years, the Society has benefited greatly from bequests both from Members and other benefactors. Most of the Society's prestigious awards and much of its library were established as a consequence of bequests. Even relatively small bequests increase in value in time and contribute to the long-term viability of the Society. Large bequests greatly increase the potential for the society to make lasting and influential contributions to intellectual life in New South Wales.

### Suggested wording of Bequests

If you intend to make a Bequest to the Society, you should forward this form to your solicitor. The following statement of intent and clauses are intended as a guide only for consideration in making your Will or alterations to it by way of a Codicil. It is important that you consult your solicitor to ensure that the wording is appropriate for the Bequest you wish to make and for your particular circumstances. The Society's solicitors would also be happy to assist you and your legal advisor free-of-charge if the Society is listed as a benefactor.

- A. I wish to leave a sum of money to: The Royal Society of New South Wales, PO Box 576, Crows Nest, NSW 1585 as follows:  
I GIVE the sum of \$..... free of all duties and taxes to The Royal Society of New South Wales, PO Box 576, Crows Nest, NSW 1585 to be applied to its general purposes and I DECLARE that the receipt of the President or other proper officer of the Society shall be a full and sufficient discharge to my Executor/Trustee for the payment of this sum and that my Trustee shall not be bound to see its application.
- B. I wish to leave a percentage of my estate to: The Royal Society of New South Wales, PO Box 576, Crows Nest, NSW 1585 as follows:  
I GIVE ..... per centum of my estate free of all duties and taxes The Royal Society of New South Wales, PO Box 576, Crows Nest, NSW 1585 to be applied for general purposes and I DECLARE that the receipt of the President or other proper officer of the Society shall be a full and sufficient discharge to my Executor/Trustee for the payment of the gift and that my Executor/Trustee shall not be bound to see to its application.
- C. I wish to leave real estate to: The Royal Society of New South Wales, PO Box 576, Crows Nest, NSW 1585 as follows:  
I wish to leave the whole of my interest free of all duties and taxes in the real estate known as ..... and situated at .....  
..... being the whole of the land comprised in certificate of title ..... to The Royal Society of New South Wales, PO Box 576, Crows Nest, NSW 1585.
